Fuji Park is an outdoor, partly shaded park. The rings will be on grass and we ask that you do not set up within 15 feet of the ring. No designated grooming area, please keep grooming at least 20 feet from ringside.

<u>From Reno:</u> Take Hwy 395 South to the Fairview exit. Take Fairview West 1.1 miles to Carson St (Hwy 395 S). Turn left and go 2.2 miles to Old Clear Creek Road. Turn right on Clear Creek, park is ¼ mile on your left across from Costco. <u>From Sacramento via Hwy 50:</u> At the junction of Hwy 50 and Hwy 395, turn right to Old Clear Creek Rd (the first street on the right). Turn right on Clear Creek and park is ¼ mile on your left.

<u>From Gardnerville/Minden via Hwy 395:</u> Take Hwy 395 North to the last street before the Hwy 50 turnoff towards Tahoe. Turn left on Old Clear Creek Rd. Park is 1/4 mile on your left.
